Notification

With regard to the notification sent vide letter no. RCSC/HRMD/7/2014/52 dated July 3, 2014; the Royal Civil Service Commission (RCSC) would like to clarify on the one month preparatory time granted to superannuating civil servants with effect from July 1, 2014.

During the consultative meetings held with some of the Agencies, it was found that the Agencies have treated the one month preparatory time as leave and had acted accordingly. The RCSC would like to clarify that this period is not to be considered as leave; rather it should be understood as a period during which the incumbent would be freed up of his/her responsibilities to ensure smooth transition to retirement. The period is to be used by the individual to:

- 1. complete handing-taking over of responsibilities;
- 2. complete necessary formalities to process retirement benefits; and
- 3. prepare for a life after exit from the Civil Service.

In this context, the RCSC would like to request all the Agencies to note this clarification and disseminate the information to the superannuating civil servants.

The RCSC solicits cooperation and support from all the Agencies in realizing its initiative towards improving the Civil Service Welfare.
