- iii. Audit clearance (valid copy)
- iv. Medical fitness certificate (original)
- v. PE ratings for the last two years (copy of FY 2014-2015 & 2015-2016)
- vi. Academic/training certificates and transcripts (copy)
- vii. Certificates of merits/achievements, if any (copy)

The basic criteria

The candidate should:

- i. Be a Bhutanese citizen.
- ii. Be able to produce audit and other clearances.
- iii. Have completed minimum active service of 12 years.
- iv. Possess excellent written and communications skills in English.
- v. Have excellent public relation skills.
- vi. Have at least 3 years of government accounting experience and knowledge in Financial Rules and Regulations.
