This is to inform all the eligible Bhutanese bidders the following clarification and changes have been made to the Invitation for Bids No. **FM/DNP/GP-45/2017/1436 dated May 04, 2017** for the procurement of cartridges and paper for the ten Ministries.

1. ITB 41.2 Post qualification requirement for procurement of cartridges and paper for the financial year 2017-2018 "Financial Capability amended as not required".
2. ITB 3.1: Amended as "A Bidder, and all parties constituting the Bidder, may have the nationality of Bhutan only".
3. ITB 14.1: Price Schedule: Bidders/ Schedule of supply are strictly required to use the prescribed price schedule provided by the procuring agencies failing to comply will lead to rejection of bids.
4. ITB 39.3 (a): For the procurement of paper bids will be evaluated for each item and the Contract will comprise the item(s) awarded to the successful Bidder. The bids will not be evaluated if the sample are not submitted along with bid as required in technical specification and the description of the goods in the price and delivery schedule.
5. ITB 39.6 Bidders **shall not** be allowed to quote more than one unit rate for each item and multiple rates will be not be accepted.
6. For the procurement of paper for the financial year 2017-2018, any brand meeting the required specification is acceptable. The bidders are required to quote one unit rate for the required specification and the multiple rates will not be acceptable.
  - ✓ SBD Section IV Bidding form "Price schedule" line item No. 1 is amended as "Photocopy paper 75 gsm: A4 size. Per ream needs to have 500 sheets, gam free performance, ideal for high speed of copying, excellent for double side printing, high opaque printing, and no smearing"
  - ✓ SBD Section VI "Schedule of supply" line item No. 1 is amended as "Photocopy paper 75 gsm: A4 size. Per ream needs to have 500 sheets, gam free performance, ideal for high speed of copying, excellent for double side printing, high opaque printing, and no smearing".
