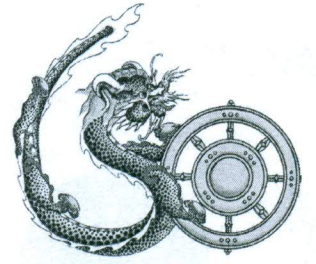

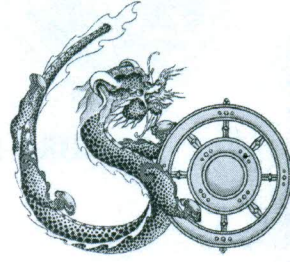

- During interview, the candidates must make a ten minutes' power-point presentation and the topic for presentation will be emailed one day before the interview.
- The shortlisted candidates must produce all the relevant documents in original especially the merit/participation certificates and publications if any, during interview.
- Kindly note that the pre-populated marks (used for shortlisting) for each candidate shall not be carried forward and the selection shall be purely based on the final selection interview.
