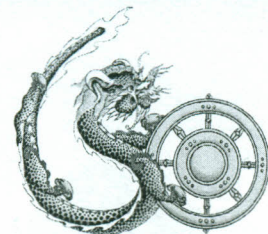

- i. Curriculum vitae – *should be generated from CSIS and have assured the accuracy of the information*
- ii. Security clearance (*Valid copy*)
- iii. Audit clearance (*Valid copy*)
- iv. Medical fitness certificate (*original*)
- v. IWP/Moderation rating for last two years (*FY 2017-18, 2018-19*)
- vi. Academic/training certificates and transcripts (*copy*)
- vii. Certificates of merits achievements, if any (*copy*)

**The basic criteria**

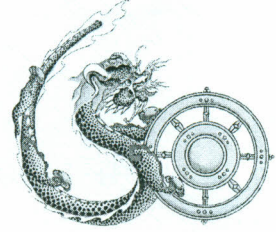
The candidate should:

- i. Be a Bhutanese citizen
- ii. Be able to produce audit and other clearances.
- iii. Have completed minimum active service of 10 years
- iv. Posses excellent written and communications skill in English
- v. Have excellent public relation skills
- vi. Have at least 3 years of field experience in Government Accounting and Budgeting with knowledge in Financial Rules and Regulations.

- vii. Have not availed such postings earlier including secondment to International Agencies and Corporations.
- viii. Have clean service record.
- ix. Be currently under Sub group '*Finance, Accounting and Budget Services*'
- x. Have completed minimum of 2 years in current position for P1 level or the officials at P2 level is promoted through open competition (as per the clause 13.7.11.5 of BCSR 2018)

In the event several candidates qualifying for a single position under the basic criteria, then the candidate fulfilling the following specific criteria will be given preference;

**Specific Criteria**

- i. Extra co-curricular activities (*as per certificate*)
- ii. Individual Achievements (*as per certificate*)
- iii. Performance Ratings (*last two years*)
