#### NOTIFICATION

#### REVISION OF ALLOWANCES AND BENEFITS

The Ministry of Finance is pleased to announce the revision of allowances and benefits of Public Servants with effect from 1<sup>st</sup> July 2014 (unless otherwise indicated). The revised allowances and benefits are as under:

#### 1. High Altitude Allowance

The High Altitude Allowance is revised as under:

Altitude'	High Altitude Allowance
For places between 10,000 feet to 12,000 feet	Nu. 2,000 per month
For places above 12,000 feet	Nu. 3,000 per month

#### 2. Difficult Area Allowance

The Difficulty Area Allowance is revised to Nu. 2,000 per Dholam subject to a maximum of Nu. 10,000 per month.

Note: The **High Altitude Allowance** and **Difficulty Area Allowance** shall be effective from the date of notification of High Altitude Area and Difficulty Area by the Ministry of Home and Cultural Affairs.

#### 3. Uniform Allowance

The uniform allowance for nurses is revised to Nu.4, 500 per annum.

#### 4. Radiation Allowance

The radiation allowance for the radiology technicians is revised to Nu.1, 500 per month.

#### 5. Salary Based Allowances

All salary based allowances have been fixed as lump sum at prevailing rates at the minimum of the revised pay scale. The lump sum allowances are Annexed to this Order as follows:

#### 8. Officiating Allowance

The officiating allowance is withdrawn and in lieu thereof, meritorious or outstanding certificates in recognition of the contributions shall be issued to avil servants officiating higher positions and due credit given for consideration for postings, fainings and promotions. This change shall be incorporated in the BCSR 2012.

#### 9. House Rent Allowance (IIRA)

House Rent Allowance (HRA) for the civil service and public servants t is granted as lump sum at 20 percent of the minimum of the revised pay scale. The HRA for the Members of Parliament is granted as lump sum at 30 percent of the minimum of the revised pay scale. The Lump-sum HRA for eligible public servants based on their position is attached as **Annexure VI-A and VI -B**.

The following conditions shall apply for the payment of HRA:

- 1. Where designated housing is provided, no HRA shall be paid
- 2. Civil servants mandated to stay in institutional houses shall not be eligible for HRA.
- 3. Public servant in whose name NHDC housing is allotted shall not be eligible for HRA and the applicable rent shall be remitted directly to NHDC by the employer. If the applicable house rent is more than the eligible HRA, the difference shall be paid by the public servants if not eligible for rent free accommodation.
- 4. Matrons/wardens of schools/institutions occupying accommodation attached to the hostel shall receive 50 percent of the HRA.
- Diplomats and regular staff attached to Embassies/Missions/Consulate abroad occupying government paid/owned accommodation shall not be required to pay house rent and also not eligible for HRA.
- 6. Civil servants on long term studies shall be eligible for 50 percent HRA after one year.

### 10. Daily Allowance (DA) and Daily Subsistence Allowance (DSA)

The daily allowances for in-country travel and DSA for travel to India and other countries have been revised. The revised DA and DSA rates are annexed as under:

- a. Daily Allowance (DA)-In-country Annexure VII
- b. DSA for India Annexure VIII
- c. DSA for countries other than India Annexure IX

#### 11. Travel Allowance (TA) - Mileage

The mileage for four-wheel vehicle is revised to Nu.16/km and mileage for two wheeler is revised to Nu.6/km.

#### 12. Leave Travel Concession (LTC)

The maximum ceiling of Nu. 15,000 for Leave Travel Concession remain unchanged.

#### 13. Travel allowance for Local Government functionaries

The annual lump sum amount for travel within the Gewog and revised daily allowance rates for travel outside the Gewog for Local Government Functionaries are as under:

#### 14. Post Service Benefits

#### a. Gratuity

The gratuity ceiling is revised from Nu. 900,000 to Nu.1,500,000 for all public servants.

#### b. Early Retirement Scheme (ERS)

The early retirement Scheme is revised as under:

- 1. For age 51 and above, 3 month's salary for every remaining year of service subject to maximum of 18 month's salary;
- For age below 51, two month's salary for every remaining year of service subject to maximum of 18 month's salary.

#### 16. Foreign Service Entitlements

The following allowances of diplomats posted in Embassies, Missions and Consulates abroad are monetized:

#### a. Carriage of Personal Effects

In lieu of the actual expenses for the carriage of personal effects including accompanied baggage and transport of personal vehicles during the transfer of diplomats from and to Headquarter, a lump sum payment will be made as given in **Annexure X A and X B**.

#### b. Home Leave Passage (HLP)

The diplomats in Embassies/Missions/Consulates abroad shall have the option to claim actual cost of the air passage upon submission of supporting documents such as original boarding passes, air tickets, etc <u>or</u> a lump sum HLP as given in **Annexure XI.** 

#### c. Furnished Accommodation

In order to minimize the cost of furnishing and problems associated with disposal of used furniture in some of the Embassies/Missions/Consulates, the following shall be implemented.

- Furniture allowance shall be paid only if furnished accommodation is not available. The furniture allowance is given as Annexure XII.
- 2. The existing furniture list shall be reviewed and revised.
- The furniture allowance shall not be paid to diplomats posted to Embassies/Missions/Consulates where government accommodation is available.

- For government owned properties, inventory list of furniture shall be maintained and replaced only after 10 years.
- Where Government accommodation is not available, Embassies/Missions shall rent or lease only furnished accommodation
- 6. The rental ceiling shall be reviewed by the Ministry of Finance periodically.
- 7. Handing taking over of furniture shall be done as prescribed under FSRR.

Other existing allowances and benefits not covered under this order shall continue to be paid at the prevailing rates. The notes to the Annexure are integral part of this order.

This order will supersede all orders, notifications and approvals regarding the payment of allowances and benefits issued in the past.

- Officials shall be entitled to only 20 percent of the DA while accompanying Head of the Government, Cabinet Ministers and Equivalent Positions.
- 8. The use of porter and pony shall be allowed only where it is absolutely necessary depending on nature of travel with prior approval of head of agency

- 5. When only lodge is provided, 50 percent of the lump sum DSA and when both food and lodge are provided, 20 percent of the lump sum DSA shall be paid. This applies to officials accompanying the Head of Government and other official delegations.
- 6. When food, lodge and out of pocket expenses is provided, no DSA shall be paid.
- 7. DSA for Gups shall be at par with Professional & Management Level (P3-P5), Mangmi at Supervisory Level, Geydrung, Tshogpas & others at Operational level of the civil service.

- 4. When only lodge is provided, 50 percent of the lump sum DSA and when both food and lodge are provided, 20 percent of the lump sum DSA shall be paid. This applies to officials accompanying the Head of Government and other official delegations.
- 5. When food, lodge and out of pocket expenses is provided, no DSA shall be paid.
- Full DSA shall be paid for the first 15 days and 50 percent of the applicable DSA for another 15 days. For stay beyond 30 days, stipend rate shall apply.
- 7. Entertainment expenses at Government cost during travels outside Bhutan shall not be permitted.
