#### Circular

Subject: Central Procurement of Cement

This is to inform all the government agencies that the Penden Cement Authority Limited (PCAL) has offered a bulk purchase rebate to the government for cement to be purchased for government construction works. The Ministry of Finance is therefore pleased to accept the offer and directs all government budget agencies to use cement manufactured by PCAL for all works estimated to cost Nu.10.00 million and above. The rebate will be directly given to the Ministry of Finance based on the consumption of cement by the various government agencies. In this regard, the following procedures should be followed for all such works being tendered henceforth with immediate effect.

- Every government agency proposing to tender out or carry out any civil works of value more than or equal to Nu. 10 Million, which involves consumption of cement, shall estimate the theoretical consumption of cement and type of cement required for that particular work.
- 2. To take advantage of the rebate offered and to enforce the use of PCAL cement, the government agency should clearly state in the Section VII- Specifications & Performance Requirements of the Bidding Document that the contractor should use PCAL cement for this work which should be lifted from the nearest PCAL Sales Depot (name the nearest depot that is Phuentsholing, Gelephu or Samdrup Jongkhar). The specifications should also state that the Contractor should arrange and pay for the transportation and make direct payment to PCAL at the price notified to the public, including the taxes, which may change from time to time. This rate should be applied in the rate analysis for all items of cement work.
- 3. On the award of work, the government agency shall notify PCAL Head Office, Gomtu of the name of the work, Contractor to whom the work is awarded including the estimated quantity of cement that will be required for the work, contract period and the published price of cement at the time of award of contract. Copy of this notification shall also be endorsed to Director General, Department of National Properties (DNP), Depot Manager from where the cement is to be lifted and the Contractor.
- 4. Further each time the contractor lifts the cement, a letter shall be issued by the agency to the depot Manager specifying the price and quantity of cement to be lifted for each

consignment with reference to the initial letter and copies to all agencies as mentioned above.

The letter issued by the agency awarding the work shall be produced by the contractor to
the Depot Manager during the purchase of cement for each consignment. The invoice
copies shall be submitted to the government agency by the Contractor for record.

6. The agency awarding the work shall submit at the end of every month a report of cement procured by the contractor for the project with invoice numbers and dates to the Director General, DNP, Ministry of Finance, Thimphu for compilation and claiming payment of the rebate from PCAL.

All government agencies awarding any kind of civil work are directed to strictly adhere to the above procedures.

#### Subject: Central Procurement of Cement

This is in continuation to the earlier Circular No. MoF/Central Procurement/2010/1246 dated November 15, 2010 regarding the procurement of cement from Penden Cement Authority Ltd (PCAL) for government budgeted works amounting to Nu. 10 million and above. It is to inform that Lhaki Cement based in Gomtu is also accepted for government works of Nu. 10 million or more, and agencies can now procure cement from Lhaki Cement also in addition to PCAL. The conditions and procurement procedures remain same as specified in the circular referred above. The cement will have to be lifted from the three depots (i.e. Phuentsholing, Samdrup Jongkhar and Gelephu) in case of PCAL whereas in the case Lhaki Cement, the agencies can lift the cement from any of their agents, where available. The list of Lhaki Cement agents at present is attached.

All the agencies are requested to adhere to the procurement procedures.
