Subject: Notification on Relieving of Finance Personnel on Transfer

In pursuant to the notification issued by the Ministry of Finance vide DNB/R-Notification/2014-15/553 dated 5th December 2014, the civil servants who are transferred should be relieved within 30 days from the effective date of transfer. The non-compliance of above notification by some of the budgetary bodies is delaying the timely completion of the transfer process thereby adversely affecting the service delivery of finance personnel.

In view of above, the respective agencies are requested to immediately comply with the above-mentioned notification and take appropriate action against the officials who have failed to join the place of posting with intimation to this office.

Notification

As per the Chapter 14 of the BCSR 2012 a civil servant who is transferred should be relieved within 30 days from the date of issue of the transfer order. However, the RCSC has observed that there is increasing noncompliance to the transfer orders issued by the Agencies as per the decision of Human Resource (HR) Committee resulting into all sort of problems for human resource management.

Therefore, in order to ensure that the civil servants comply with the transfer orders issued by the HR Committee of the agencies, all Budgetary Bodies shall stop the payment of salary in the relieving Agency to the concerned civil servants after 30 days from the effective date of transfer.

This notification shall come into immediate effect.
