1. All bids must be submitted in a sealed envelope marked as “**Quotation for Air Ticket**” to the Director, Directorate Services, MoF latest by **20th November, 2018** before 11.00AM and will be opened at 11:30am on the same day.
2. The rate should be quoted as per the sector given above and will be selected for the **most economical route**.
3. **Airline and seats must be confirmed while submitting the quotation** and submit confirmed itineraries. However, bidders are requested not to quote for budget airlines.
4. The validation of fares and availability of seats should be as per the details mentioned above.
5. The successful bidder should submit the photocopy of every air ticket along with their invoices for payment
6. Unconditional quotations like an increase of fares or changes of airlines at the time of travel are not accepted.
7. Tender documents should contain a photocopy of valid trade license issued by Ministry of Economic Affairs.
8. Tenders should be accompanied with a lump sum amount of **Nu.100, 000/-** only as earnest money deposit in the form of draft/cash warrant issued in favour of the Director, Directorate Services, MoF.
