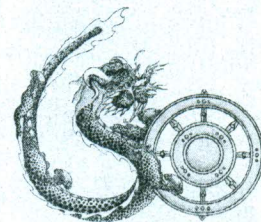

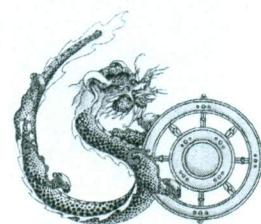
1. During interview, the candidates must make a ten minutes power-point presentation and the topic for presentation will be emailed one day prior to the interview.
