EOIs should include, besides CV, a cover note with, description of similar assignments, experiences in similar conditions, and summary of individual's capability, availability of appropriate skills and any other relevant information. The EOIs would be reviewed on the basis of the following requirement:

- Masters in Public Policy or Economics, Chartered Accountant, CPA, ACCA or equivalent.
- At least of 10 years' experience in the field of Public Financial Management (mandatory criteria).
- Should have experience of at least one demonstrated PIM assessment based on a recognized diagnostic framework as team leader/project manager in the last five years (mandatory criteria).
- Fluency in English is mandatory (oral and written); fluency in *Dzongkha* is a plus.
