TENDER FORM

TERMS AND AGREEMENT

- 1. The successful tenderer is required to pay 25% of the tendered amount at the time of acceptance of tender or the next working day and the balance amount within ten (10) working days from the date of acceptance, failing which the offer will be cancelled and the 25% deposit shall be forfeited.
- 2. The successful tenderer shall lift the vehicle(s) on the last day of final payment from the auction yard.
- 3. The earnest money of the successful tenderer will be adjusted against the offer and the earnest money of the unsuccessful tenderers will be refunded immediately after finalising the winner.
- 4. The earnest money of the successful tenderer will be forfeited if he/she refuses to accept the tender.
- 5. It will be assumed that the tenderer has inspected the vehicles and is satisfied as per the condition mentioned in the table below that they are bidding for.
- 6. Inspection of the vehicles shall be allowed strictly from 9-27 November, 2020 during office hours. No inspection shall be allowed thereafter. Complaints of any mismatch of the condition of the vehicles will not be entertained later.
- 7. Ownership transfer of vehicles shall be approved only to the tenderer who submitted the bid and any applicable transfer tax have to be paid by the buyer to the RSTA Office at the time of ownership transfer as per the RSTA existing rule.
- The Tender form must be submitted to the Auction Yard by 28th November, 2020 at 1000 Hours and the tender will be opened at 1030 Hours on the same day at Auction Yard.
- 9. If the offer price is less than the Reserve Price then that particular lot shall be considered as cancelled.
- 10. The opening committee shall read the quoted bid amount to all the participants and hand over to the evaluation committee for evaluation. The tender will be awarded to the highest bidder after the evaluation.
- 11. The successful tenderer shall be informed in writing and instruct to deposit the amount as per serial no. 1 above.
- 12. Any tenderer who wishes to attend the tender opening shall be provided a *Zoom link* and will be able to witness the entire opening process and bid prices.
- 13. If there is a tie between bidders then a lucky dip shall be held as 'YES" or "NO" to decide the ultimate winner.
