The Department of National Properties is pleased to announce the public auction of Vehicle, Two-Wheeler and Obsolete items through sealed bid tender. Therefore, interested tenderers are invited to participate through Sealed tender along with the earnest money of Nu 20,000 (Ngultrum Twenty Thousand) only in cash warrant/demand draft. The cash warrant/demand draft must be addressed to the **Director General, DNP, Thimphu.**

The tender form can be collected from the Auction Section by paying Nu. 300 (Ngultrum Three Hundred) only (non-refundable) from 23<sup>rd</sup> August till 3<sup>rd</sup> September 2021. The tender must be submitted to the Auction Section, DNP on 4<sup>th</sup> September 2021 at 10AM and shall be opened at 10:30AM on the same day at DNP Conference Hall followed by awarding of winning lots. The interested tenderers must inspect the lots physically in the auction yard as well as those located in various places. The mere act of submission of tender implies that the tenderers accept without question the terms and conditions attached.

## TENDER FORM

### TERMS AND AGREEMENT

1. All interested tenderers are invited to participate through sealed tender along with the earnest money of Nu 20,000 (Ngultrum Twenty Thousand) only in cash warrant/demand draft. The cash warrant/demand draft must be addressed to the Director General, DNP, Thimphu.
2. The successful tenderer is required to pay 25% of the tendered amount at the time of acceptance of tender or the next working day and the balance amount within ten (10) working days from the date of acceptance, failing which the offer will be cancelled and the 25% deposit shall be forfeited.
3. **The winning tenderer shall lift the vehicle/two-wheeler/obsolete items (s) on the last day of final payment. After the final payment day is lapsed a demurrage charge of Nu. 500 shall be imposed on every lot.**
4. The earnest money of the successful tenderer will be adjusted against the offer and the earnest money of the unsuccessful tenderers will be refunded immediately after finalizing the winner.
5. The earnest money of the successful tenderer will be forfeited if he/she refuses to accept the tender after announcement of the winning bidder.
6. It will be assumed that the tenderer has inspected the vehicles and is satisfied as per the condition mentioned in the table below that they are bidding for.
7. Inspection of the vehicles, two wheelers and obsolete items shall be allowed strictly from 23<sup>rd</sup> August to 3<sup>rd</sup> September 2021 during office hours. No inspection shall be allowed thereafter. Complaints of any mismatch of the condition of the vehicles, two-wheeler and obsolete items will not be entertained later.
8. Ownership transfer of vehicles shall be approved only to the tenderer who submitted the bid and any applicable transfer tax has to be paid by the buyer to the RSTA Office at the time of ownership transfer as per the RSTA existing rule.
9. The Tender form must be submitted to the **Auction Yard** by 4<sup>th</sup> September, 2021 at 1000 Hours and the tender will be opened at 1030 Hours on the same day at **DNP's Conference Hall and awarding of winning lots shall be done on the same day.**
10. If the offered price is less than the Reserve Price, then that particular lot shall be considered as cancelled.
11. The opening committee shall read the quoted bid amount to all the participants and hand over the tender documents to the evaluation committee for evaluation. The tender will be awarded to the highest bidder after the evaluation.
12. The successful tenderer shall be informed in writing and instructed to deposit the amount as per serial no. 1 above.
13. Any tenderer who wishes to attend the tender opening shall be provided a *Zoom link* and will be able to witness the entire opening process and bid prices.
14. If there is a tie between bidders then a lucky dip shall be held as 'YES' or 'NO' to decide the ultimate winner.
15. The tender committee reserves the right to accept or reject the bids without assigning any reason whatsoever.
16. The mere act of submission of tender implies that the tenderers accept without question the terms and conditions attached.
17. It is mandatory for all the bidders to quote price both in figure and in words. In case of discrepancy between the figure and words the words will prevail over figures.
18. The opening committee shall project the rates of the highest bidder during the opening of the bid to the bidders via Zoom/at Auction Yard for utmost transparency.
