

Request for Expressions of Interest

The Ministry of Finance, Royal Government of Bhutan has obtained a grant titled *Bhutan Multi Donor Fund on Public Financial Management (PFM-MDF) (P162196)* and intends to apply the grant proceeds from its component for the following services:

“Consultancy Services for development and integration of systems and reports development and enhancement”

The Department of Public Accounts under the Ministry of Finance, the Royal Government of Bhutan now invites eligible **individual international consultants** to indicate their interest in providing the services as stated in Term of Reference. The main objective of this assignment is the development of documentation system for cluster finance services, development of portal for identification of source of payment from e-PEMS and enhancement and development of reports. A Consultant will be selected in accordance with the procedures set out, in the World Bank's Guidelines:

The services are expected to be rendered for four months which is subject to renewal based on the performance of the selected consultant. A terms of reference is attached.

EOIs should include, besides CV, a cover note with, description of similar assignments, experiences in similar conditions, and summary of individual's capability, availability of appropriate skills and any other relevant information. The EOIs would be reviewed on the basis of the following requirement:

- Master Degree in Information Technology, Computer Science or equivalent with a minimum of 5 years work experience in system administration and software development; Or a Bachelor Degree in Information Technology, Computer Science or equivalent with a minimum of 7 years of work experience in system administration and software development.

- At least five (5) years of software development experiences .NET, MSSQL, API & Web Services.
- Experience in working in similar countries like Bhutan with similar environment, nature and IT projects on ePayment/accounting, budgeting and planning would be an added advantage.
- Demonstrated strong communication and leadership skills with the ability to promote.
- Collaborative team environments and work well with cross-functional groups.
- Fluency in English is mandatory (oral and written).
