### TERMS AND CONDITIONS

1. All the bidders shall pay Nu. 300.00/- (Nu. Three hundred) only, as entrance fee, which shall be non-refundable.
2. Any representative can register and can avail a token on behalf of the interested bidder/s.
3. Each bidder shall deposit the earnest money of Nu. 5,000.00 (Nu. Five thousand only) in cash with the Department of National Properties (DNP), Ministry of Finance (MoF), a week before the date of auction to qualify to bid for the auction. On receipt of the EMD, a token card shall be issued to identify the qualified bidder. A person without a token shall not be allowed to bid. Issuance of tokens and inspection of lots shall not be entertained on the auction day.
4. The EMD of the topmost winning bidder shall be retained until the auction is completed as security for subsequent bids to be offered in respect to the remaining items. On completion of the auction, the earnest money of the topmost winning bidder shall be adjusted against the auction value of items won by the respective bidder. The earnest money of unsuccessful bidders shall be refunded immediately on the same day after completion of the auction.
5. The topmost winning bidder, whose bids are accepted shall deposit a spot payment of 25% (in cash) of the auctioned value at the fall of the hammer. The earnest money deposits shall be forfeited if the bidders fail to deposit the 25% of spot payment.
6. The balance of 75% shall be paid within 10 (ten) working days from the day of auction before 4 PM. The winning bidder has the option to make the 75% payment in cash or demand draft drawn in favor of the Director General, Department of National Properties (DNP), Ministry of Finance (MOF) from the Bank of Bhutan, Thimphu. Failure to pay within stipulated days; the accepted bid shall be canceled and the deposits of 25% of auction value shall be forfeited.
7. The topmost winning bidder for a different vehicle types whose bid is accepted by the auction committee shall take delivery/lift the vehicle at his/her own cost within 10 (ten) working days from the date of the auction upon full payment.
8. Failure to lift/deliver on the stipulated days shall result in the forfeiture of the deposits and the same vehicles shall be listed in the next auction.
9. The transfer of ownership for a vehicle shall be completed within 15 days from the date of issue of ownership certificate.
10. The buyer shall be levied 1% transfer tax for vehicles sold through auction. The transfer tax shall be paid to the Road Safety and Transport Authority (RSTA) at the time to proceed with ownership transfer in addition to other taxes levied by RSTA. A copy of ownership transfer certificate shall be duly shared



pwith the Auction Yard, DNP or concerned authority (if on "as is where is" basis) to take delivery of the vehicle/lot within stipulated working days from the date of auction.

11. The topmost winning bidder shall lift the vehicle/lots on the last day of final payment from the auction yard within stipulated days. In the event of the failure the winning bidder shall be levied Nu 500/day for occupying the space.
12. In regard to dismantling of structure, the topmost winning bidder shall lift within one month from the date of the auction. In the event of full payment to DNP, if such items are not lifted within the stipulated days the deposits shall be forfeited and the same shall be included in the next auction.
13. The dismantling work includes the demolition of the structure, lifting of the materials and clearing the debris of the area. The duration of the work shall be one month from the day of issue of the work order.
14. The successful bidder for the dismantling work shall have to make a security deposit of 20% of the bid value in DD drawn in favor of Director General, DNP. The 20% deposits shall be refunded on completion of the dismantling work upon submission of successful completion endorsed by the concerned agency.
15. The auction committee reserves the right to accept the bid on the spot or at any subsequent date. In case of any dispute or problem with regard to the auction, the decision of the committee shall be final and binding.
16. The DNP envisage that interested parties bidding for any items have inspected the lots prior to the auction and that the bid offered is at their own liberty and judgment. No complaint will be entertained at a later date.
17. All registration number plates of the government vehicles sold through public auction shall be removed upon taking delivery by the winning bidders.

  
Officiating Director General
