The Ministry of Finance, Royal Government of Bhutan has obtained a grant titled ***Bhutan Multi Donor Fund on Public Financial Management (PFM-MDF) (P162196)*** and intends to apply the grant proceeds from its component for the following services:

“Hiring of National Consultancy firm for the Development of Mobile Daily Allowance and Travel App”

The Department of Public Accounts (DPA) under the Ministry of Finance, the Royal Government of Bhutan now invites eligible **National Consultancy Firm** to indicate their interest in providing the services as stated in **Term of Reference (ToR)**.

The main objective for developing the Mobile Daily Allowance and Travel app are to:

- a) Replicate the entire TA/DA functionalities and processes of the Web based application system to make it mobile friendly.
- b) Add functionality to capture image/picture with geo-coordinate locations
- c) To ensure interoperability and flexibility TA/DA over multiple platforms such as via mobile as well as web based.
- d) Prevent double claims/payments and minimize under-table tours
- e) Enhance user experience with the utilization of inbuilt features of mobile phones like GPS, camera, etc.
