## Introduction

The Department of Planning, Budget and Performance (DPBP), Ministry of Finance is pleased to issue the 1<sup>st</sup> Quarter Budget Performance Report for the FY 2022-2023 ending September 30, 2022.

The report highlights the budget and expenditure performance for the 1<sup>st</sup> quarter including domestic revenue and grants realized and loans contracted to finance the fiscal deficit. Through this report the Department seeks to inform the Government, citizens and other relevant stakeholders on the performance of the resources, budget and expenditure to enhance transparency in accordance with the global practices as well as responsibility bestowed upon by the Public Finance Act 2007 and amendment thereof. This report has been prepared in accordance with the budget classification framework adopted in the National Budget Report.

## 1. The Government's Budget

Both the resources and expenditure have increased by 4 percent and 3 percent respectively in the 1<sup>st</sup> quarter. The increase in resource is mainly on account of incorporation of Nu.1,804.371 million under donor support for implementation of various programs and activities during the FY. The details of amounts incorporated under different donors are shown in Table 1. The programs and activities will be implemented by the relevant budgetary agencies.

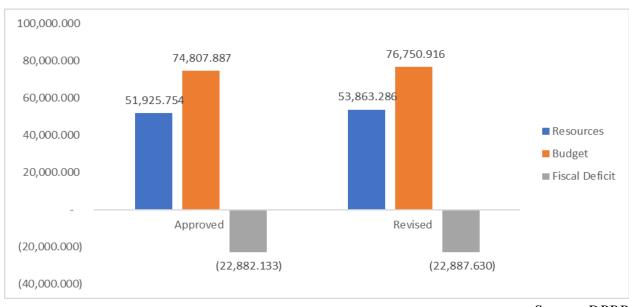


FIGURE 1: BUDGET, RESOURCE & FISCAL BALANCE

The summary of total resources, expenditure and fiscal balance as compared to the original estimates is shown in Figure 1.

The fiscal balance as a percentage of GDP (Nu.207,925.00 million) increased from 11 percent to 11.01 per cent at the end of 1<sup>st</sup> quarter due to increase in external borrowings (Project Tied borrowings) amounting to Nu. 5.500 million.

## **1.1.** Current and Capital Budget

The current budget has increased by 0.27 percent which is equivalent to Nu. 99.090 million during the quarter as compared to the approved budget. The increase in current expenditure is mainly attributed to supplementary incorporation of Thromde funds amounting to Nu.95.00 million and Nu.19.700 million for the National Seed Center. The details of the variance are shown in Table 2.

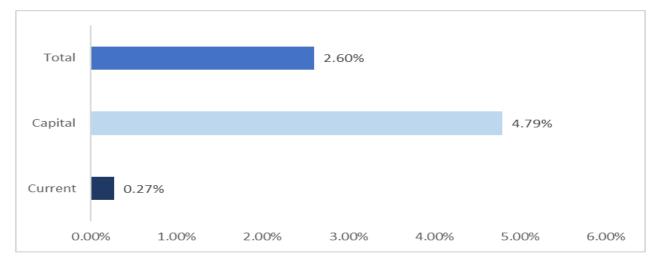

On the capital front, the budget has increased by 4.79 percent which is equivalent to Nu. 1,843.939 million as compared to the approved budget. The increase in the capital budget is on account of incorporation of external grants of Nu. 1,804.371 million and internal grants of Nu. 23.958 million. Furthermore, as is admissible by Financial Rules and Regulations (FRR) Nu.15.610 million has been re-appropriated from current to capital budget as well.

## 2. Summary of Actual Resource, Release and Expenditure

This section reports the position of actual resource, release and expenditures. It also covers information on the year-on-year comparison of fiscal position.

## 2.1. Realized resource, release and expenditure

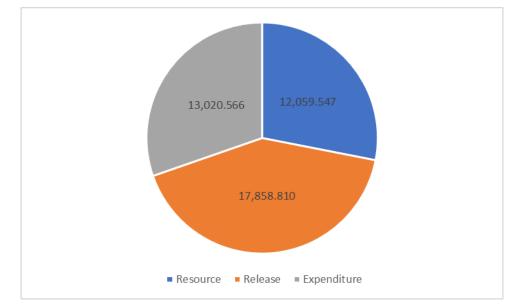
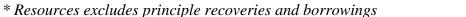


FIGURE 3: REALIZED RESOURCES, RELEASE AND EXPENDITURE

The following Figure 3 reflects actual resources realized, budget released, and expenditure incurred during the 1<sup>st</sup> quarter. The excess release as against the realized resources during the 1st quarter was mainly attributed to the RGoB pre-financing of donor projects as an interim measure until donor fund releases are received and the excess expenditure is against adjustment of prior year advances.

The expenditure reported, however, is less as compared to the resource realized as well as the release provided on account of unadjusted advances since the economic activities do not generally pick up until the  $2^{nd}$  quarter due to completion of procurement processes.

## 2.2. Fiscal Summary for the 1<sup>st</sup> Quarters of the two FYs

Table 3 illustrates the year-on-year comparison of fiscal performance for the 1<sup>st</sup> quarter of the two FYs. During the FY, the total resources performance has increased by 15.32 percent as compared to the last FY for the same period.

The expenditure performance has also increased by 1.64 percent as compared to the last FY of the same quarter. Due to increase in the receipts (revenue & grants), the fiscal deficit has decreased by 130.04 percent as compared to the last FY for the same period.

The comparison is further substantiated in Figure 4.

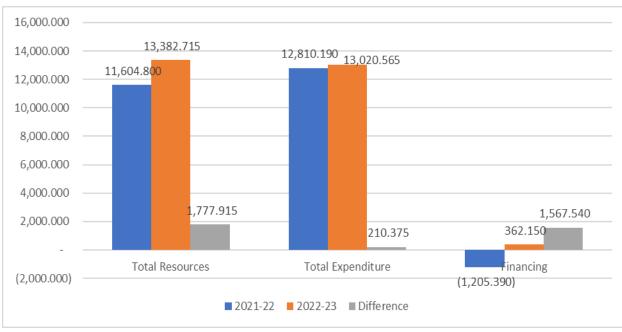

## 2.3. Resources Vs Revenue Performance

Table 4 illustrates performance of total resources realized against estimates for the FY. The total resource realized at the end of the 1<sup>st</sup> quarter is 22.12 percent against the estimates. Of the total resources realized, domestic resource is 65.02 percent, external grant is 48.75 percent and other receipts is 45.97 percent. The external borrowings and recoveries realized is 3.17 percent and

#### **3.** Expenditure Developments

This section reports the expenditure performances for the current FY and the comparative statement for the 1<sup>st</sup> quarters of the two FYs.

## 3.1. Release and Expenditure by function

The actual expenditure by function is as shown in Table 5. Against the release of Nu. 19,937.540 million, the expenditure reported is Nu. 15,020.879 million (Current – Nu. 9,100.717 m, Capital – Nu. 3,919.848 m and Repayment- Nu. 2,000.313 m) which is 18 percent of the revised budget at the end of the 1<sup>st</sup> quarter.

The total release at the end of the 1<sup>st</sup> quarter against the revised budget constitutes 24 percent while the total expenditure stands at 18 percent. The overall expenditure excludes advances sanctioned during the FY.

## **3.2.** Expenditure summary by object classification

The actual current expenditure as of 30<sup>th</sup> September, 2022 is Nu. 9,100.717 million which is a 2 percent increase as compared to the actual current expenditure of the previous FY 2021-22. The increase in the current expenditure was mainly on account of increase in interest payment and mandatory expenditure with 5 percent and 11 percent increase respectively, as compared to FY 2021-22.

The actual capital expenditure excluding the Lending and Repayment as of 30<sup>th</sup> September, 2022 is Nu. 3,919.848 million which is a slight decrease of 0.10 percent as compared to the same period in FY 2021-22.

The decrease in the capital budget was on account of rationalization measures put in place to reduce wasteful and non-economic spending. As such, expenditure on training, awareness and procurement of vehicles/plants/equipment/office furniture and have decreased as compared to the same period in the previous FY.

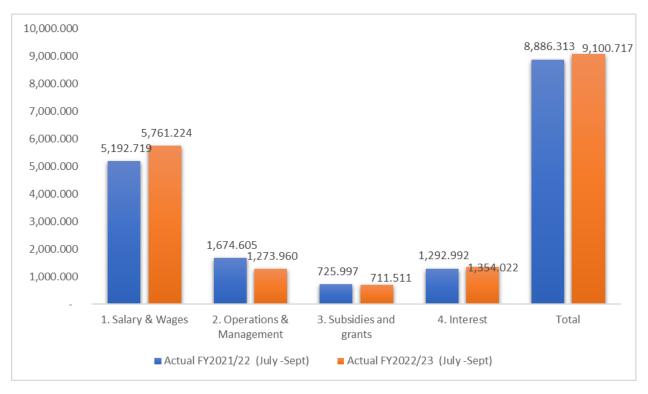
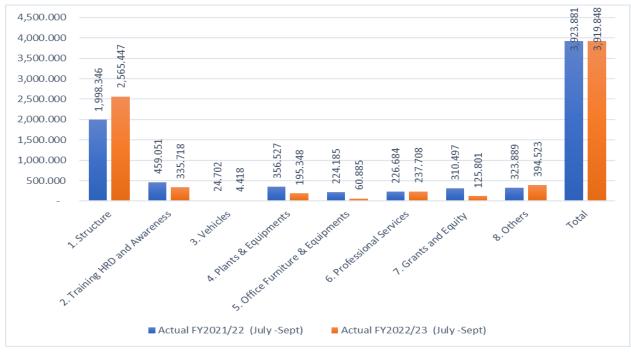


FIGURE 5: RECURRENT EXPENDITURE COMPARISON BETWEEN TWO FYs.

## 3.3. Expenditure summary by Sector

The Table 7 below represents the sector wise expenditure summary for the 1<sup>st</sup> quarter of the two FYs. The overall expenditure performance shows an improvement of 2 per cent as compared to last FY during the same period.

## 4. Transfers: Annual Grants, Subsidies and Equities:

Table 8 shows the list of budgetary support rendered in the form of transfers. The transfers are mainly allocated as annual grants for local governments, subsidies and equities for State Owned Enterprises and grants to other non-budgetary agencies such as Civil Society Organizations. During the FY, the overall grants expenditure performance has decreased by 12 percent as compared to FY 2021-22.

The overall decrease in the expenditure performances was attributed from the expenditure performance under grants components which includes the expenditure reported by the Local

Governments with a 12 percent decrease as compared to last FY. The expenditure performance for subsidies has also declined as compared to last FY mainly due to decrease in budget allocation for interest subsidy to Drukair, BAIL and NHDCL.

#### 5. General Reserve

During the fiscal year, Nu. 8,052.987 million was provisioned under the General Reserve in meeting the unforeseen expenditures which are to be transferred to the agencies after fulfilling the established criteria. As such, the highest transfer during the quarter was made for acquisition of properties which accounts for 37 percent of the total revised reserve.

#### 6. Financing

This section covers the financing position of the government as of 30<sup>th</sup> September 2022.

#### 6.1. External Borrowings

During FY, out of the total estimated borrowings of Nu. 5,470.518 million from international lenders like ADB, World Bank, IFAD, and JICA in the form of Program and Project-Tied borrowings, Nu. 173.500 million has been received by the end of 1<sup>st</sup> quarter which is around 3 percent of the total estimates.

The table below illustrates performance of external borrowings against the estimates for the FY.

## 6.2. Domestic Borrowings

The opening balance of T-bills stood at Nu. 15,500 million at the beginning of the 1<sup>st</sup> quarter. During the quarter, the Government issued T-bills worth Nu. 15,000 million to finance the resource gap and Nu.15,500 million was redeemed thereby managing the short-term cash requirement of the Government. The outstanding T-bills at the end of 1<sup>st</sup> quarter is Nu.15,000 million.

The T-bills issued, redeemed and outstanding during Q1 is shown in Table 11.

## 7. Budget Provided for COVID-19

The effort to contain the spread of COVID-19 continued in the first quarter through various measures such as mandatory quarantine and other facilities. By the end of the 1<sup>st</sup> quarter, the total budget of Nu. 60.813 million was provided to various budgetary agencies for COVID-19 containment measures out of which Nu. 55.777 million was transferred from budget provisions kept under the General Reserve and Nu. 5.036 million was directly incorporated under respective budgetary bodies which were received from the donors.

However, with the reopening of borders on September 23, 2022 and lifting of mandatory quarantine of inbound travelers, the expenditure is expected to decrease in the subsequent quarters.

The budget summary for COVID-19 containment measures incorporated by agency is shown in Table 12.

## Conclusion

The overall resources have increased due to incorporation of external grant support of Nu.1,804.371 million. There has been a slight increase in the fiscal deficit from 11 percent to 11.01 percent of GDP mainly on account of increase in project-tied borrowings amounting to Nu.5.500 million.

The performance of total resources at the end of 1<sup>st</sup> quarter stands at 25 percent against the estimates which is higher compared to the last FY which was about 20 percent during the same period. Similarly, the domestic resources performances stand at 33 percent against the revised estimates which is also higher compared to the last FY which was 21 percent during the quarter.

The expenditure performance including lending and repayment as compared to revised budget stands at 18 percent which is an increase of 1 percent as compared to the last FY 2021-22 which was about 17 percent during same period.

With the reopening of borders and relaxation of COVID-19 restrictions, the implementation of capital activities is expected to pick up in the subsequent quarters.
