### Terms and Condition

- 1. All the bidder shall pay Nu.300.00/ (Nu. Three hundred) only, as entrance fee, which shall be non-refundable.
- 2. Any representative can register and can avail a token on behalf of the interested bidders.
- 3. Each bidder shall deposit the earnest money of Nu. 5000.00 (Nu. Five Thousand) only in cash to the Department of Procurement and Properties, Ministry of Finance a week before the auction to qualify him/herself to bid for the auction. On receipt of the earnest money, a token is issued to identify the qualified bidder. A person without a token shall not be allowed to bid for tokens and inspection of lots shall not be entertained on the same day.
- 4. The earnest money of the topmost winning border shall be retained until the auction the auction is completed as security for subsequent bids to be offered in respect to the remaining items. On completion of the auction, the earnest money of the topmost winning bidder shall be adjusted against the auction value of items won by the respective bidder. The earnest money of unsuccessful bidders shall be refunded on the next working day (i.e Monday) day after completion of the auction.
- 5. The topmost winning bidder, whose bids are accepted, shall deposit a spot payment of 25% (in Cash or mBoB) of the auction value at the fall of the hammer.
- 6. The balance 75% shall be paid within 10 (TEN) working days from the day of auction before 4PM. The winning bidder has the option to make the 75% payment in the form of cash or demand draft in favor of the Director, Department of Procurement and Properties (DPP), Ministry of Finance (MoF) from Bank of Bhutan, Thimphu. Failure to pay within stipulated days or time, the accepted bid shall be canceled and deposits 25% of auction value shall be forfeited.
- 7. The topmost winning bidder for a different vehicle type whose bid is accepted by the auction committee shall take delivery/ lift the vehicle at his/her own cost within 10 (TEN) working days from the date of the auction upon full payment. After the final payment day is lapsed, a demurrage charge of Nu.500 shall be imposed on every lots.
- 8. Failure to lift /deliver on the stipulated day shall result in the forfeiture of the deposits and the same items shall be listed in the next auction.
- 9. In regard to dismantling of structure, the topmost winning bidder shall lift within one month (ONE MONTH) from the date of the auction. In the event of full payment to DPP, if such items are not lifted within the stipulated days shall result in cancellation and the same shall include in the next auction.
- 10. The transfer of ownership for a vehicle shall be completed within 15 days from the date of issue of ownership certificate.
- 11. The buyer shall be levied 1% transfer tax for vehicles sold through auction. The transfer tax shall be paid to the Road Safety & Transport Authority (RSTA) at the

time to proceed with ownership transfer in addition to other taxes levied by RSTA.A copy of ownership transfer certificate shall be duly shared within the auction yard, DPP and should be produced to RSTA at the time of ownership change.

- 12. The successful bidder for dismantling works shall have to make a security deposit od 20% of the bid value, (In Demand Draft drawn in favor of Director, DPP, Thimphu) which shall be refunded on completion of the dismantling works and subject to a letter of successful completion being provided by the concern agency. The dismantling works include the demolition of the structure, lifting of the materials and clearing the debris of the area. The duration of the works shall be one month from the day of issue of work order.
- 13. The auction committee reserves the right to accept the bid on the spot or at any subsequent date. In case of any dispute or problem with regard to the auction, the decision of the committee shall be final and binding.
- 14. The DPP shall assume that interested parties bidding for items have inspected the lots prior to the auction and that the bid offered is at their own liberty and judgment. No complaint will be entertained at a later date.
- 15. All registration number plates of the government vehicle sold through public auction shall be removed upon taking delivery by winning bidders.
