# MESSAGE FROM THE DIRECTOR GENERAL



am pleased to present the National Revenue Report of the Department of Revenue & Customs for the year ended 30<sup>th</sup> June 2021 (FY 2020-2021). This report reviews the domestic revenue performance during the year.

Total domestic revenue collected during the year was Nu. 35,855.445 million. The tax revenue decreased by 9.4 percent and tax to GDP represented 11.2 percent.

Bhutan's response to the pandemic remains exemplary. His Majesty the King's extraordinary leadership supported by the Government's persistent effort to implement public health safety measures while vaccinating almost the entire population of Bhutan with vaccine doses have so far kept the nation safe.

Bhutan has made international headlines for its successful management of the COVID-19 pandemic and, in particular, its vaccination rollout.

Bhutan has outstanding, compassionate leadership and the safety protocols needed to defend the nation against the pandemic. Our king, as head of country, and the prime minister and health minister led a collaborative

effort against the virus that enabled the implementation of targeted policies that have minimised the health and socio-economic impacts of the COVID-19 pandemic. Every choice we make has the potential to alter the course of this new wave of infections – whether to protect or endanger the lives of those around us.

# DOMESTIC REVENUE PERFORMANCE FISCAL YEAR 2020-2021

The total net domestic revenue realised during the FY 2020-2021 was Nu. 35,855.445 million, representing 20.3 percent of GDP. The net domestic revenue decreased by 1 percent as compared to the previous FY 2019-2020 of Nu. 36, 218.876 million. As compared to the past fiscal year 2019-20, the overall tax revenue decreased by 9.4 percent and Profit Transfer from the Royal Monetary Authority also decreased by 33.6 percent, thereby decreasing the overall net revenue.

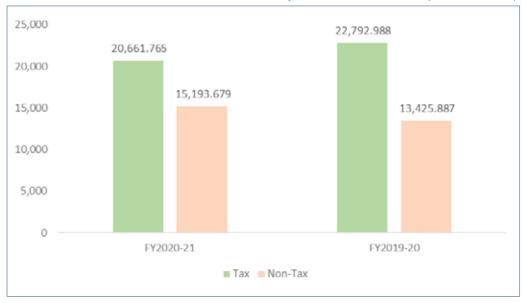
#### **TAXES**

Tax revenue comprises four heads, namely Taxes on Income, Profits and Capital Gain, Taxes on Property, Taxes on Goods and Services, Taxes on International Trade and Transactions and Other Taxes.

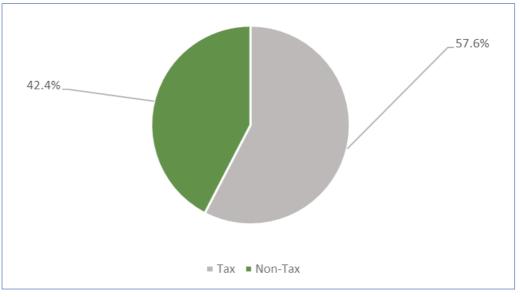
Tax revenue collected in the FY 2020-2021 was Nu. 20,661.765 million, recording a decrease of 9.4 percent as compared to FY 2019-2020 of Nu. 22,792.988 million.

It contributed 57.6 percent to the total revenue.

#### Taxes on Income, Profits and Capital Gains

This mainly comprises Corporate Income Tax, Business Income Tax, and Personal Income Tax. The revenue collection under this was Nu. 10,941.288 million during the FY 2019-20.

#### **Corporate Income Tax (CIT)**

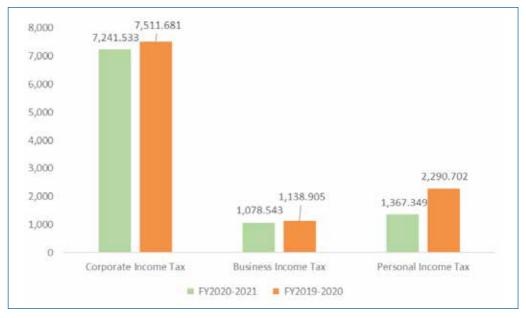
The CIT collection for the fiscal year was Nu. 7,241.533 million which is a decline of 3.6 percent as compared to the previous fiscal year 2019-2020. The decline in CIT collection is attributed to the facilitation provided to the tourism and allied sectors in paying the Corporate Income Tax for the income year 2020 on an instalment basis. The total CIT collection accounted for 20.2 percent of the total revenue. For Druk Holding and Investments, CIT paid Nu. 2,089.356 million.

#### **Business Income Tax (BIT)**

During the FY 2020-2021 the BIT collected was Nu. 1,078.543 million which is a decline of 5.3 percent as compared to the previous fiscal year. BIT contributed 3 percent to the total revenue composition. The reduction is due to the general decline in economic activities triggered by the COVID-19 Pandemic.

The year 2020 recorded 10,442 (28.25%) business units, one of the highest thus far, declared non-operational, leading to a drastic fall in business income tax collection.

#### Personal Income Tax (PIT)

The PIT collected was Nu. 1,367.349 million, recording a decrease of 40.3 percent. The decline in PIT collection was due to enhancement in the basic exemption threshold from Nu.200,000 to Nu.300,000 with effect from income year 2020. The reduction is further attributable to an increase in specific exemption under dividend income and enhancement in education expense limit to Nu.350,000 per child under general deductions. On the whole, PIT contributed 3.8 percent to the total revenue collection.

#### **Taxes on Property**

Taxes on Property comprise Recurrent Taxes on Immovable Property and Taxes on Capital Transactions.

The revenue collected under Taxes on Property was Nu. 138.915 million with an increase of 410 percent as compared to the previous fiscal year 2019-2020 with the collection of Nu. 27.239 million. This was mainly due to increase in compliance as a result of downward revision of tax rate on transfer of ownership of both Property and Motor Vehicle.

Recurrent Taxes on Immovable Property (Dzongkhag Municipality)

Recurrent Taxes on Immovable Property consists of Municipal Tax, House Tax, and Underdevelopment Land Tax. The revenue collected under this was Nu. 8.976 million, with an increase of 82.1 percent as compared to the previous fiscal year.

#### **Taxes on Capital Transactions**

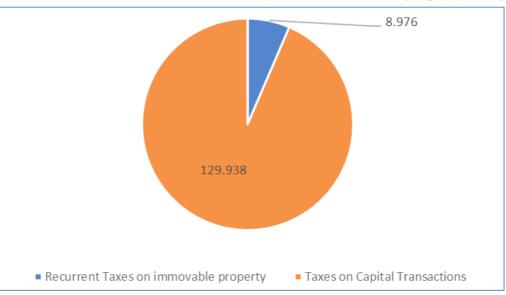
Taxes on Capital Transactions includes, Property Transfer Tax, and Motor Vehicle Ownership Transfer Tax. The revenue under this source was Nu. 129.938 million, with an increase of 482.4 percent as compared to the previous fiscal year and contributing 0.4 percent to total revenue.

#### **Taxes on Goods and Services**

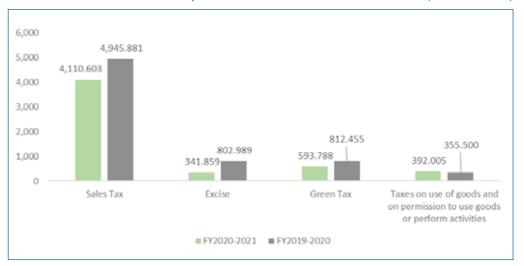
Taxes on Goods and Services comprises Sales Tax, Excise, Green Tax and Taxes on Use of Goods and on Permission to use Goods or Perform Activities.

The revenue collected under Taxes on Goods and Services was Nu. 5,438.2545 million, with a decrease of 21.4

percent as compared to the previous fiscal year. Due to the pandemic, the businesses had been adversely affected. As such, there was a fall in collections of sales tax from hotels and fall in import of goods. Further, the collections of green tax and customs duty was adversely affected with the fall in import of goods and services.

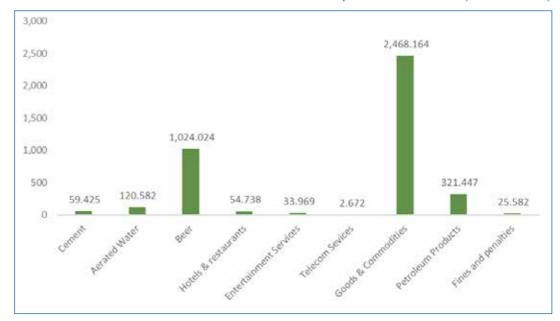
The exemption of 5 percent sales tax on telecom services from January 2020 has also affected the revenue collection.

#### **Sales Tax**

Sales Tax is collected on Cement, Aerated Water, Beer, Hotels and Restaurants, Entertainment Services, Telecom Services, Goods and Commodities, Vehicles, and Petroleum Products. The Sales Tax collection for this fiscal year is Nu. 4,110.603 million, with a decrease of 16.9 percent as compared to the previous fiscal year. It contributed 11.5 percent to the total revenue collection; the decrease was mainly from Cement and Telecom Services.

*Beer*: Sales Tax on Beer decreased by Nu. 413.772 million as compared to the previous fiscal year, with a decrease of 28.8 percent. The decrease could be attributed to abruption in the supply chain due to the pandemic and frequent movement restrictions imposed at the southern border towns. It contributed 2.9 percent to the total revenue.

*Hotels and Restaurants:* Under Sales Tax on Hotels and Restaurants the revenue collected was Nu. 54.738



million, contributed 0.2 percent to total revenue. It decreased by 87.6 percent as compared to last fiscal year. Hotel industry was the worst hit sector amongst the business sectors due to the surge of pandemic and therefore, huge decrease in revenue collection.

**Telecom Services:** Collection under Telecom services during the fiscal year was Nu. 2.672 million with a drastic decrease from Nu. 322.784 million, with a decrease of 99.2 percent as compared to last fiscal year. The decrease in revenue from this sector is attributed to granting of exemption on Telecom Services.

*Goods and Commodities:* Collection of Sales Tax on Goods and Commodities was Nu. 2,468.164 million, with an increase of 11.6 percent. It contributed 6.9 percent to the total revenue contribution.

**Petroleum Products:** Sales Tax on Petroleum collected was Nu. 321.447 million, and the increase was by 8.6 percent. While the volume of import of petroleum products witnessed a

decreasing trend, increase of sales tax collection can be attributed to the global increase of price on petroleum products.

#### **Excise**

Excise duty is a domestic levy collected from the Army Welfare Project Limited. Domestic excise duty collected was Nu. 341.859 million with a decrease of 57.4 percent as compared to the previous fiscal year. The decrease was mainly due to pandemic. Further, due to international border closures, the export has decreased.

During the fiscal year 2019-2020 there was collection from the Excise Duty Refund of Nu. 123.339 million, which was a balance collection from the previous fiscal year.

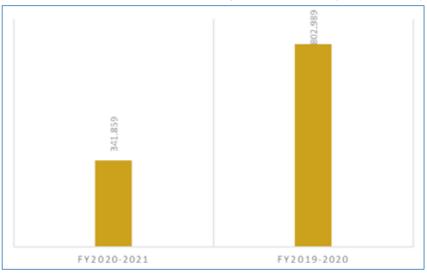
#### **Green Tax**

The Green Tax consists of collections from Motor Vehicle and Fuel. The Green Tax collected for the fiscal year was Nu. 593.788 million, with a decrease of 26.9 percent. The decrease was mainly due to decrease in import of fuel as a result of travel restrictions. It contributed 1.7 percent to the total net revenue.

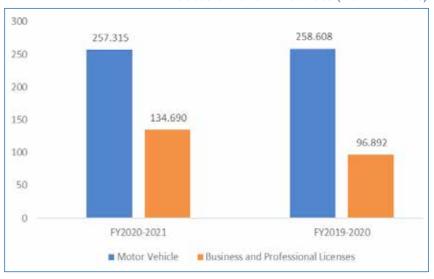
# Taxes on Use of Goods and on Permission to use Goods or Perform Activities

It consists of collection from motor vehicle and business and professional licences, during the fiscal year revenue collected under this head was Nu. 392.005 million which contributes to 1.1 percent of total revenue. There was an increase of 10.3 percent as compared to last fiscal year.

#### **Taxes on International Trade and Transactions**

Taxes on International Trade and Transactions includes customs duty. The collection for customs duty during the fiscal year was Nu. 555.082 million with an increase of 18.6 percent as compared to the previous fiscal year which contributed 1.5 percent of total revenue collection.

#### Other taxes

Other taxes are passenger service charge, duties, and royalty. The revenue collected under other taxes was Nu. 4,842.090 million with an increase of 9.1 percent and it contributed to 13.5 percent of total revenue.

#### **Passenger Service Charge**

Passenger service charge is the revenue collected from airport tax and surcharge from passengers, the revenue collected during the fiscal year was Nu. 3.534 million with a decrease of Nu. 108.583 million with 96.8 percent as compared to previous fiscal year this was mainly due to pandemics; there were no international tourist and travel restrictions.

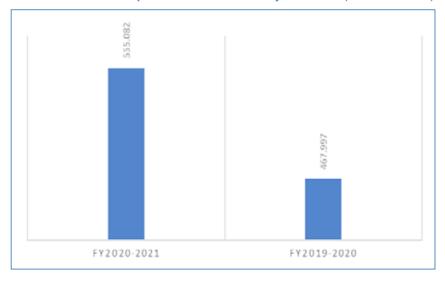
#### **Duties**

Duties consist of legal stamp and revenue stamp duty collections. The revenue collected was Nu. 15.797 million with a decrease in collection as compared to the previous fiscal year by 19.4 percent.

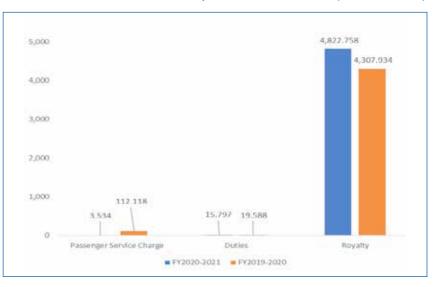
#### Royalty

The royalty is collected under sustainable development fees, forest products, mines and minerals, hydropower and other royalties. The royalty collected was Nu. 4,822.758 million during the fiscal year 2020-2021 with an increase by 12 percent as compared to the previous fiscal

year. This was mainly due to an increase in collection from mines and minerals and hydropower royalty by 130.1 percent and 44.6 percent respectively.

There was no collection from Sustainable Development Fees during the fiscal year as there was no tourism related activities unlike in the last fiscal year where there was a collection of Nu. 1,108.213 million under this account head.

#### **OTHER REVENUE**

Other revenue consists of Property Income and Health Contribution. During the fiscal year 2020-2021 Nu. 14,039.480 million was collected as other revenue, with an increase of 16.9 percent as compared to the previous fiscal year and it contributed 39.2 percent to the total revenue.

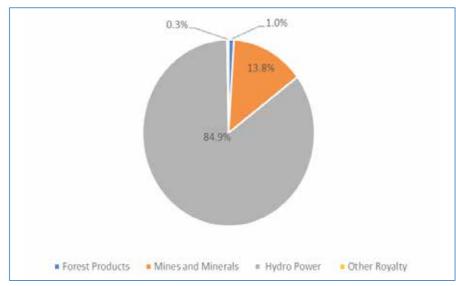
#### **Property Income**

Property Income includes Interest Receipts, Dividend, Net Profit Transfer from RMA and MHP and Miscellaneous Rent. The total collection recorded under this source was Nu. 14,025.289 million, with an increase of 16.4 percent as compared to the previous fiscal year. It contributed 39.1 percent to the total revenue.

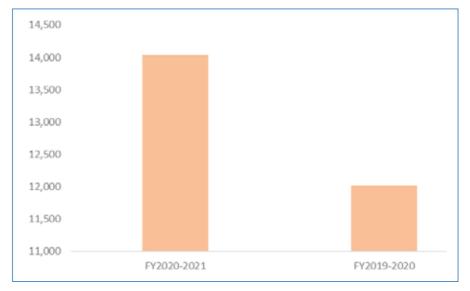
#### **Interest from Corporation**

The revenue under this source was Nu. 1,570.640 million in fiscal year 2020-2021, increased by 77 percent by amount of Nu. 683.252 million. It contributes 4.4 percent to the total revenue.

#### **Dividend**

The total dividend received was Nu. 3,039.052 million, out of which DHI Dividend was Nu. 3,020.052 million and the dividend from other corporations was Nu.19 million. The overall dividend decreased by 34 percent as compared to last fiscal year mainly due to decrease in dividend from DHI by 33.6 percent as compared to last fiscal year. It contributed to 8.4 percent of total revenue.

#### Withdrawals from Income of Quasi-corporations

Revenue under this source increased by 30.5 percent to Nu. 9,376.581 million. During the fiscal year 2020-2021 net profit transfer from Mangdechhu Hydro Power increased by 43.9 percent as compared to the previous fiscal year and it contributed 20.6 percent to the total revenue.

Whereas, net profit transfer from the Royal Monetary Authority decreased by 50.5 percent as compared to the previous fiscal year.

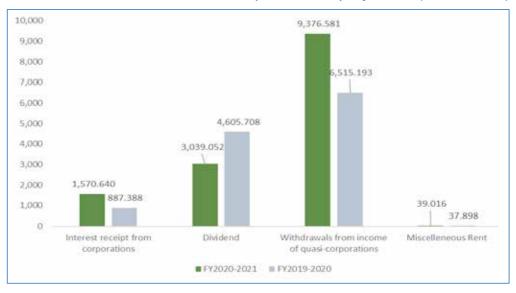
#### Miscellaneous Rent

The revenue collection in the fiscal year 2020-2021 was Nu. 39.016 million, the collection under this source was increased by 3 percent as compared to the previous fiscal year. It contributed 0.1 percent to total revenue.

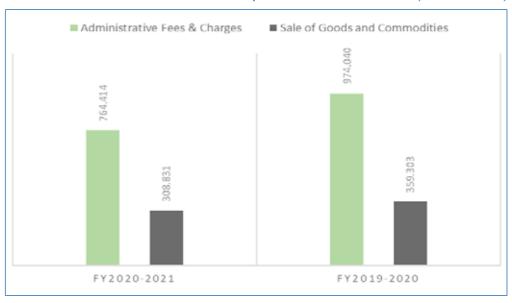
#### **Social Contribution**

Health Contribution for the fiscal year was Nu. 293.750 million. This amount was reimbursed to the Bhutan Health Trust Fund with the adjustments.

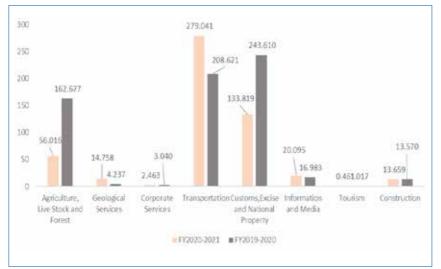
#### Composition of Property Income (Nu. in millions)



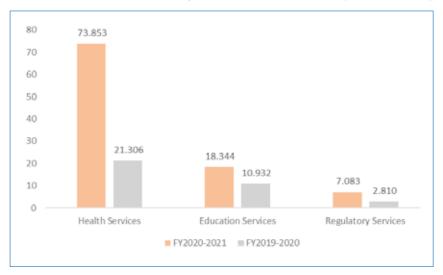
#### Composition of Current Revenue (Nu. in millions)

#### **Composition of Social Services (Nu. in millions)**

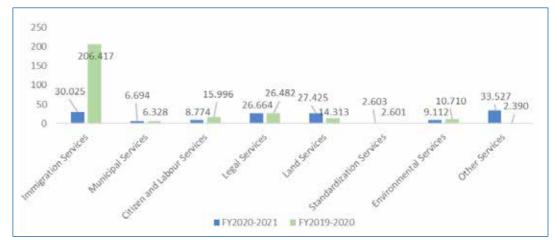


# CURRENT REVENUE FROM GOVERNMENT AGENCIES

Overall revenue under this source was Nu. 1,073.245 million which was a decrease of 19.5 percent as compared to the previous fiscal year. It contributed 3 percent to the total revenue.

Current Revenue consists of Administrative Fees and Charges, Sale of Goods and Commodities, General Services and Miscellaneous Revenue.

#### **Administrative Fees and Charges**

Under this head, it includes Economic Services, Social Services, and General Services; revenue collected under this source was Nu. 764.414 million which was a decrease by 21.5 percent. It contributed to 2.1 percent of total revenue.

#### Sale of Goods and Commodities

Sale of Goods and Commodities, includes Economic Services, General Services and Miscellaneous Revenue; the collection under this source was Nu. 308.831 million with a decline of 14 percent. It contributed 0.9 percent to the total revenue.

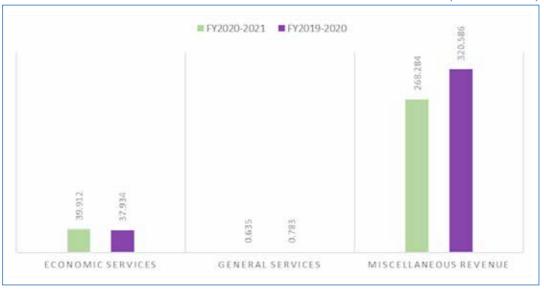
Miscellaneous Revenue decreased by 16.3 percent as compared to the previous fiscal year.

# CAPITAL REVENUE FROM GOVERNMENT AGENCIES

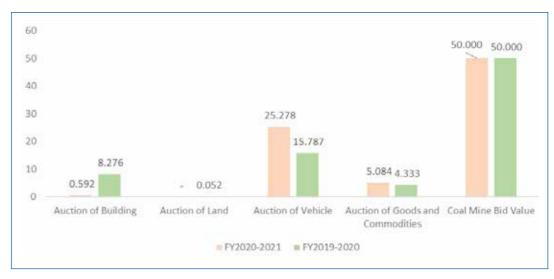
Capital Revenue for the fiscal year 2020-2021 was recorded at Nu. 80.954 million which was an increase of 3.2 percent as compared to the previous fiscal year. Capital Revenue consists of the auction of building, land, vehicle, goods and commodities and coal mine bid value.

The increase was mainly due to auction of vehicles, and goods and commodities. The Capital Revenue contributed 0.2 percent to total revenue.

#### Sale of Goods and Commodities (Nu. in millions)



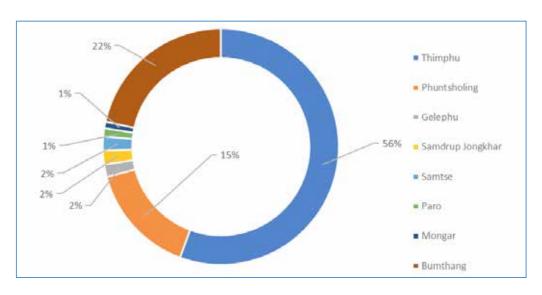
#### Composition of Capital Revenue (Nu. in millions)



# TAX EXPENDITURE

The Tax foregone in the year 2020 was estimated at Nu. 5,010.062 million.

For the Income Year 2020, the total tax expenditure from exempted business units and from units on tax holiday stood at Nu. 67.08 million. A total of 10,732 business entities were either exempted from tax or under tax holiday. Section 11, chapter 2 of Fiscal Incentives Act of Bhutan 2017 exempts income tax to small and micro businesses located in the rural areas. The incentive was granted in the year 2017 and was further extended till 2024 in the Third Session of the Third Parliament. The incentive is provided primarily to promote the growth and development of the economic opportunities, livelihood and employment opportunities in rural areas. In the income year 2020, Nu. 34.70 million from 10,571 small and micro business units in rural areas beyond the Thromde and Dzongkhag Municipal boundary have been exempted. Gelephu region saw the maximum number of units falling under the tax-exempted bracket, recording 1939 units forgoing Nu. 7.88 million business income tax while the Bumthang region had the lowest number of exempted units at 543 units. The Royal Government with an objective to stimulate private sector growth, to generate employment and attract foreign investments has formulated various fiscal incentives. The Fiscal Incentives Act of Bhutan 2017 was targeted to promote thrust sectors such as education, tourism, ICT, manufacturing, CSI's for balanced economic growth. As of 31st July 2021, there are 161 business units from various sectors availing tax holiday as per Fiscal Incentives Act of Bhutan



2017 thereby recording a tax expenditure of Nu. 32.38 million under direct tax. RRCO Thimphu alone has 87 business entities availing tax holidays forgoing Nu. 21.37 million of tax followed by RRCO Paro with 24 units forgoing 6.25 million in income tax. This is mainly because the Thimphu and Paro region has most of the high-end hotels and education sectors which are on tax holiday. On the other hand, Bumthang and Samtse region has 5 and 2 units respectively on tax holiday but the taxes forgone from those units are nil as businesses have declared loss.

# **REGIONAL REVENUE COLLECTION**

Regional Revenue and Customs Office (RRCO) Thimphu region contributes to the major revenue collection of 55.6 percent, followed by Bumthang of 21.6 percent, this was mainly due to profit transfer from Mangdechu under Bumthang RRCO, then Phuntsholing with 15.2 percent. Samdrup Jongkhar, Samtse, Paro, Gelephu and Mongar contributed to 1.9 percent, 1.9 percent, 1.1 percent, 17 percent and 0.9 percent respectively.
